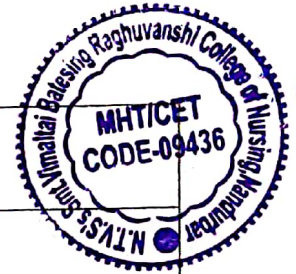
Minutes of Meeting of Authority

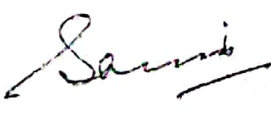
